- I. Call to Order/Roll: 6:03 pm
- II. Discussion/Action Items
  - a. Executive Director's Report
    - i. Bingo 2/26 at 6:00 pm
    - ii. Birdies for Charity 2<sup>nd</sup> through the 7<sup>th</sup>. Can still promote and place bids.
    - iii. Arizona Tax Credit Funds Website (aztaxcreditfunds.com) -- guaranteed to double our investment. Option 1, \$1,000 on investment, guaranteed \$2,000 return (name under Cancer Support). Option \$5,000, guaranteed \$10,000 (logo). Processing fee is paid by the company. There is a website and paper print. Other AZ childhood cancer groups are part of this website including Children's Cancer Network and Amanda Hope. Ashley is going to follow-up with the organizations on what they thought about this organization. October 1 is renewal. Contract runs until September 30.
  - b. Committee Reports
    - i. Finance Report \$23k deposit into our account from PayPal from the golf tournament. Still around \$250k in bank account.
    - ii. Strategic Plan
      - 1. Process for approving camp programming: discussion on creating a procedure for ideas for the program. Series of drop down categories for programming committee to provide.
        - a. Virtual Teen Night \$50/a month. Play a variety of games. Motion to approve by Debbie Accomazzo; second Ildi Laczko-Kerr. Passes unanimously.
        - b. Drive in Movie Night still collecting ideas. Not approved at this time. Need more information.
        - c. Fall retreat in person, 50 campers/20 volunteers. Not approved at this time. Board is not considering large in person events given current pandemic situation.
      - 2. Volunteer survey on programing was not successful. Only 18 responses.



- 3. Caregiver survey. Draft from M discussed. Board version also discussed. More detailed and data driven information provided by board version. Motion to approve board version of the caregiver survey by Lindsey Gray; second Debbie Accomazzo. Passes unanimously.
- 4. Creation of camp site criteria- site committee. How to evaluate any camp site. Ildi created an excel spreadsheet for potential criteria. More detailed analysis will be forthcoming to evaluate all potential camp locations for 2022.
